Boil Water Notice

On July 27, 2022, the Texas Commission on Environmental Quality (TCEQ) required the Pennington WSC, 2280009, to issue a Boil Water Notice (BWN) to inform their customers on and off of FM 1280 & FM 2781 intersection to 4476 FM 1280 to boil their water prior to consumption. Children, Seniors, and persons with weakened immune systems are particularly vulnerable to harmful bacteria and all customers should follow these directions.

To ensure destruction of all harmful bacteria and other microbes, water for drinking, cooking, and ice making should be brought to a rolling boil and then boiled for two minutes.

In lieu of boiling, individuals may purchase bottled water or obtain water from some other suitable source for drinking water or human consumption purposes.

When it is no longer necessary to boil the water the public water system officials will notify customers that the water is safe for drinking water or human consumption purposes.

Once the boil water is no longer in effect, the public water system will issue a notice to customers that rescinds the boil water notice in a manner similar to this notice. Please share this information with all the other people who drink this water, especially those who may not have received this notice directly. You can do this by posting this notice in public places or distributing them by hand or mail

Boil Water Rescind Notice

On July 29, 2022, the Texas Commission on Environmental Quality (TCEQ) required the Pennington WSC, 2280009 to issue a Boil Water Notice (BWN) to inform their customers on and off of FM 1280 & FM 2781 to 4476 FM 1280 that due to the presence of contaminants or an interruption in service, water from our system must be boiled prior to consumption.

Children, Seniors, and persons with weakened immune systems are particularly vulnerable to harmful bacteria and all customers should follow these directions.

Our system has taken the necessary corrective actions to restore adequate pressure, disinfectant levels, and/or bacteriological quality and has provided TCEQ with testing results that indicate that the water no longer requires boiling as of 07/29/22.
